Required vaccinations for ALL extended stay guests, day stay guests, and spa appointment guests: DOGS: Rabies, Distemper/Parvo & Bordetella (Kennel Cough)Extended stay guests are required to have had a Heartworm test and fecal exam in the past year with a negative result for both**. The canine flu vaccine is highly recommended. CATS: Rabies, FVRCP (FVRCP w/Leukemia for roaming privileges) and fecal exam. All guests are required to be on heartworm, intestinal parasite, flea and tick prevention.**



Rules, Regulations & Waiver

INJURIES & ILLNESS: At the BoardRoom, we strive to provide your pet with wonderful care and a fun experience during their stay. Although animals are supervised at all times, injuries can still occur while dogs are playing together such as scratches, cuts or sprained joints. Such injuries are rare, but they happen at all pet resorts. In addition, while infrequent, dogs can get into fights, even under close supervision. In addition to injuries, it is possible for dogs to transfer illness such as upper respiratory infections and kennel cough, even with the required vaccinations and boosters. Such illnesses do not occur often and all dogs must have the necessary vaccinations to check-in.

AGE & GENDER: Dogs and cats of all ages are allowed at the BoardRoom as long as they meet the facility's criteria of vaccinations. All dogs participating in doggie daycare must be spayed or neutered (small breed 4-6 months of age, large breed 8-12 months of age). The same rules apply for cats with roaming privileges in our cat room. Puppies must have completed their 3rd series of puppy vaccinations at least one week prior to reservation to be eligible to board.

PHOTOGRAPHS: I understand that photographs or video recordings are taken of the facility, pets, customers and staff on a regular basis for, among other things, use in advertising by the BoardRoom. I acknowledge that all such images therein are the property of the BoardRoom. I give my consent, permission, and authorization, without compensation to me, to use, reproduce, and alter the images.

WAIVER: 1. I agree that the BoardRoom will not be liable for any claims of injury, illness, damage or death to my dog during its stay and that under no circumstances will the BoardRoom be liable for consequential damages. 2. I certify that I have informed the BoardRoom of all dog and human aggression. I agree that I am responsible for any harm caused by my dog while in the care of the BoardRoom. I shall indemnify the BoardRoom against any claims made against it or for losses or damages suffered by the BoardRoom as a result of my dog. 3. I understand that, in the event my dog appears to be ill or at significant risk of experiencing a medical problem, the BoardRoom will attempt to contact me for instructions prior to seeking veterinary care from our partner hospital, Cumberland Animal Hospital. If I cannot be reached, I agree that the BoardRoom may use its reasonable discretion in seeking veterinary care AT CUMBERLAND ANIMAL HOSPITAL and that I will be responsible for all related expenses. 4. I assume full responsibility for payment of all veterinary services rendered, including, but not limited to, diagnosis, treatment, necessary grooming, medical supplies, and boarding. I agree to make such payments directly to the attending veterinarian or reimburse the BoardRoom if direct payment cannot be made. 5. I certify that I have informed the BoardRoom staff of any and all previous medical conditions, allergies or issues that my pet has.

This agreement and waiver is valid from the date below and grants permission for future veterinary care without the need for additional authorization each time the BoardRoom @ Cumberland for one or more of my dogs or cats.
